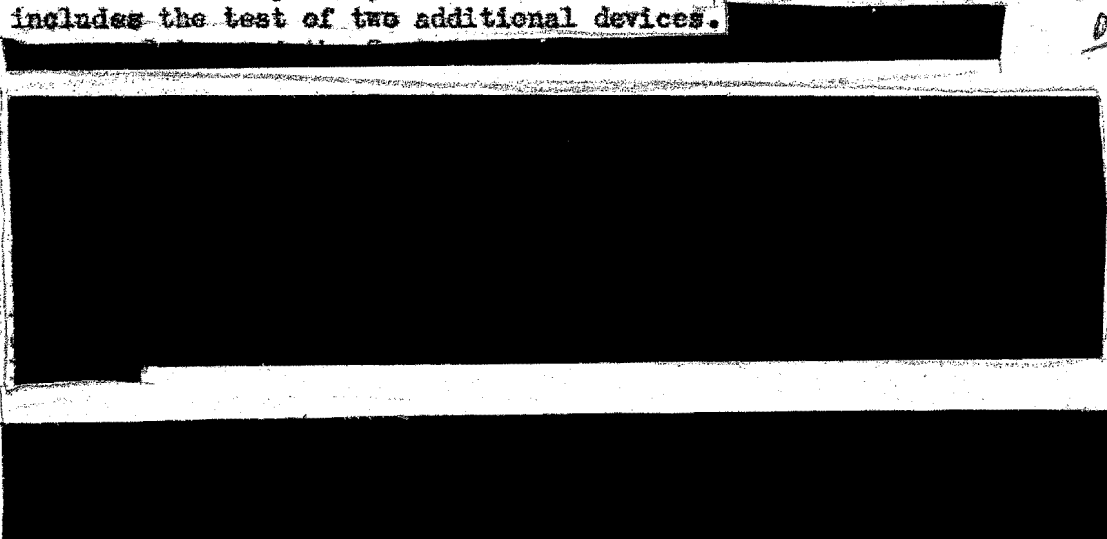

Dear General Loper:

I refer to our letter of October 17, 1955, informing you of the proposed Operation REDWING and requesting your comments and support, and to your reply of November 21, which assured us of the full support of the Department of Defense for this test series.

Further developments at the laboratories require that additional shots be included in the test program. The Commission has approved a test program which, besides the shots contained in Revision No. 6 dated December 7, 1955, to CTG 7.1 General Concept No. 1-55, J3-51, includes the test of two additional devices.
