SOUTHWICK HAS PARTICIPATED IN INTER-AGENCY DELIBERATIONS RESULTING IN NATIONAL SECURITY COUNCIL DIRECTIVE FOR IVY INFORMATION PLAN AND IS LIAISON BETWEEN AEC INFORMATION SERVICE AND DEFENSE DEPARTMENT OFFICE OF PUBLIC INFORMATION.

PARAGRAPH. SOUTHWICK IS PREPARED TO STAY WITH YOU IF YOU WISH UNTIL POST-SHOT EFFECTS ARE DETERMINED SO FAR AS NEED OF ANY PUBLIC INFORMATION STATEMENT OR ACTION IS CONCERNED.

PARAGRAPH. IN VIEW OF HIS MATURE JUDGMENT IN AEC PUBLIC INFORMATION FIELD AND INTIMATE KNOWLEDGE OF INFORMATION PHASES OF IVY PLANNING I BELIEVE HIS PRESENCE WILL BE HELPFUL TO BOTH OF US PARTICULARLY IN THE EVENT OF PRES-ENTLY UNFORESEEN INFORMATION PROBLEMS.
