

Dear Dr. Cox:

Since attending the AFSWP meeting on IVY (Restr) I have found that the altitudes I used for three of the canisters on Mike Shot were 10,000 feet too low due to a clerical error in copying the original data. This changed both the ranges as computed from the travel timer and the altitude correction factors for pressure and range. This error has been rectified on the inclosed overpressure vs. distance curve and canister position plot for Mike. The correction improves the internal consistency of the data and slightly increases the estimate of the effective blast yield. Since I did not quote any numbers in the brief summary statement I gave you, and the qualitative conclusions remain the same, I think we can let it stand.

A preliminary report on Project 6.11 should be ready for distribution within two or three weeks. The final report should be out by 1 June 1953 at the latest.
