The Atomic Energy Commission with the cooperation of the Navy Department is making plans for sending a party of twelve contract employees to and within Pacific Islands in the Marshall Islands, not foreign controlled, during the last week of June 1948 for an estimated period of six weeks. This party will be headed by Dr. Lauren E. Donaldson of the Applied Fisheries Laboratory, University of Washington, Seattle, Washington.

Arrangements have been made with the Navy Department for the issuance of travel orders and identification cards. These identification cards will be issued by Naval Intelligence Officers and contain the following information, verified by birth certificates and/or naturalization papers:

- Weight
- Photograph
- Fingerprints
- Statement of American citizenship
