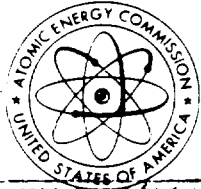

Holmes & Narver records show the total Atoll area after Operation Redwing was approximately 1,731 acres and that after Operation Hardtack it was approximately 1,674 acres.
