REFERENCE YOUR MESSAGE PDB:ART-212, UNDERSTAND JTF-8 IS PROVIDING HONOLULU WITH TWO LISTINGS OF AEC EQUIPMENT THAT TRUST TERRITORY GOVERNMENT WANTS TO RETAIN AT BIKINI. FIRST LIST INCLUDES ELEVEN ITEMS WHICH DASA INTENDS TO REPLACE BY JANUARY 1970 OR EARLIER FROM DOD RESOURCES NOW LOCATED AT LAKE MEADE, KILKEN AND CLARKSVILLE. IF NECESSARY, NVO SHOULD ARRANGE WITH JTF-8 FOR INSPECTION OF THIS EQUIPMENT AND ADVISE DMA OF ITS SUITABILITY. SECOND LIST INCLUDES TEN ITEMS WHICH DASA INTENDS TO REPLACE WITH NEW EQUIPMENT BY JUNE 1970. REQUEST NVO DETERMINE IF THIS DATE IS SATISFACTORY.
