Dear Miss Morris: *Kai,*

The plans for our March-April Medical Survey are about complete. We plan examinations at Majuro, Ebeye, and then by LCU at Utirik, Rongelap, Bikini and Eniwetok. You have received a copy of our proposed schedule and a list of personnel. I am enclosing an updated schedule with this letter. The following items will be needed (they can be purchased either in Honolulu or Kwajalein or borrowed from Kwajalein):

I. FOOD

- 10 cases apples ) (Ebeye, Bikini, Eniwetok)
- 10 cases oranges )
- 172 pkg. Koolaid (2 different flavors - Outer Islands)
- 1 1/2 gross peanut butter crackers, prepackaged (Majuro)
- 8 cases Coca Cola (Ebeye)
- Doughnuts (Ebeye - Dr. Knudsen will order - made on Ebeye)

The following will be distributed on Utirik and Rongelap to provide food during the course of our examination period (this would cover ~175 people for 5 days):

- 1200 lb. rice
- ✓360 cans beef stew ( 1 1/2 lb. ea.)
- ✓240 cans Spam
- 4 bags doughnut mix
- 48 lbs. shortening (Spry, Crisco)
- 120 cans baked beans (16 oz. ea.)
- 12 cases powdered milk

If you could find the beans, stew, or Spam in institutional sizes it would be satisfactory and probably less expensive.

We will need a carry-all or covered truck with benches to transport people at Ebeye and also a second vehicle for general use. We will need to move our supplies from Kwajalein to Ebeye, along with stevedore help. Perhaps the Liktanur can stop by Ebeye prior to departure. We understand it is planned to move the medical trailer to Ebeye in time for these examinations. There will be a number of additional items such as nails, U bolts, turnbuckles, light-bulbs, Romex connectors, wire nuts, hooks, electrical plugs, curtain hangers, etc., which Doug Clarens would pick up when he arrives at Kwajalein. We would also like to be sure there is a 220-volt electrical outlet near the bow of the LCU so we can tie in to our shore facilities with LCU power.

Our medical shipment of 34 boxes was airfreighted to you on February 15th. Boxes 1 through 7 should be shipped to Majuro by March 8th and the remainder shipped to Kwajalein by March 11th.

Reservations for 8 will be needed at the Eastern Gateway, Majuro, from Wednesday, March 9th, through Sunday, March 13th (Trust Territory time). This does not include Dr. Knudsen, who will be arriving at Majuro earlier. Will you contact him to get his schedule and make his necessary Majuro reservations? We will need two car rentals for these five days. It would be convenient if they were at the airport when we arrive.

I gave you a copy of our Honolulu hotel reservation requests and also the "Mac" and "Air Mike" flights desired when I saw you at Kwajalein. It is my understanding that the Trust Territory personnel make their own reservations between Kwajalein and Majuro. The Trust Territory group from Majuro will be Sebia Shoniber, Nelson Zetkia, Peter Bien and Dr. Ezra Riklon. Dr. Kumangai will be joining us from Saipan; and you will note on our revised schedule that John Anjain, an interpreter from Ebeye, will also accompany us. I will write Ezra and remind him to get "Air Mike" reservations for his group to Kwajalein.

We have also ordered some government surplus supplies to be shipped directly to you. These may not arrive in time for this trip but, in any event, should be transhipped to Kwajalein.

I gave you the reservation request of Dr. Wolff. He will be going "Air Mike" Kwajalein to Ponape, April 5th and Ponape to Honolulu, April 8th (U.S. time).
