1. MR JIM MILLER, ERDA REP AT ENEWETAK, HAS ADVISED THAT MARSHALLESE LIVING AT ENEWETAK ATOLL WILL BE INCLUDED IN THE WHOLE BODY COUNTER ANALYSIS TO BE CONDUCTED BY BROOKHAVEN LABS IN EARLY OCTOBER.
2. BECAUSE OF THE EXCHANGE OF FAMILIES AT JAPTAN ISLAND THIS ANALYSIS WILL OCCUR SOON AFTER THEIR ARRIVAL AND WILL REQUIRE CAREFUL PREPARATION OF THE PEOPLE WHO PROBABLY HAVE NOT BEEN SUBJECTED TO SUCH AN EXAMINATION BEFORE. REQUEST THAT DISTADREP BE PRESENT DURING THIS PERIOD TO COORDINATE TRANSPORTATION REQUIREMENTS AND TO SERVE AS AN INTERPRETER TO ASSIST BROOKHAVEN PERSONNEL.
