A. PAGE 10, LINE 17 ADD, "IN SITU OPERATORS OF THE RADIATION LABORATORY," BETWEEN "(FRST)" AND "AND THE LOJWA". RATIONALE: THE IN SITU VANS WILL BE STATIONED AND OPERATED IN THE NORTHERN ISLANDS. THE TWO/AGE MECHANICS/DRIVERS ASSIGNED TO THE RAD LAB WILL BE STATIONED AT LOJWA.

E. PAGE 12, LINE 9 ADD "AND MEDICAL TEAM" BETWEEN "TEAM" AND "WIE". RATIONALE: REALIGN USAF TEAM DEPLOYMENT.

F. PAGE 17, LINE 12: CHANGE "BLADDERS" TO READ "BULK STORAGE TANKS". RATIONALE: THE ARMY DOES NOT INTEND TO USE BLADDERS IN ANY APPLICATION.

D. PAGE A-1-2, LINE 6: DELETE MEDICAL DEPLOYMENT TO 2 AUG 77.

RATIONALE: BALANCE OF THE MEDICAL TEAM DEPLOYS 15 JUN 77.

E. PAGE A-1-2: DELETE ALL USAF ENTRIES AFTER 1 SEP 77.

RATIONALE: ACTUAL REDEPLOYMENT DATES AND DEPLOYMENT DATES FOR REPLACEMENT PERSONNEL CANNOT BE ESTABLISHED UNTIL REVIEW IS MADE OF TRAVEL AND TRAINING TIME EN ROUTE TO ENEWETAK IS DETERMINED.

B. PAGE C-2-F-3, LINE 9: CHANGE TO READ, "THE FIRST WILL DISPERSE WITH A MINIMUM OF THREE MEMBERS DESIGNATED AS EOD TECHNICIAN OR SPECIALIST AMONG...". RATIONALE: THE MANNING REQUIREMENT FOR THE FIRST REQUIRED THREE EOD MEMBERS DURING THE INITIAL DEPLOYMENT WITH FUTURE REDUCTION TO TWO BUT THE MUNITION DISPOSAL CAREER FIELD HAS BEEN IDENTIFIED AS A POSSIBLE SOURCE FOR MEMBERS OF THE FIELD TEAM.

RATIONALE: ASSUMES PLAN WILL CONTINUE TO FORECAST SHIPPING REQUIREMENTS THROUGH 15APR 2000. PROVIDES NECESSARY PROCEDURES IN THE EVENT A BACKLOG SHOULD OCCUR.

B. D-15, LINE 15: CHANGE "COMMANDER" TO READ "SURGEON" AND "MEDICAL" TO READ "AEPOMEDICAL". RATIONALE: AEPOMEDICAL EVACUATION IS THE CORRECT TERMINOLOGY AND IS A RESPONSIBILITY OF THE JTG SURGEON.

C. PAGE D-18, LINES 6-7: CHANGE SENTENCE TO READ, "THE ARMY WILL MAINTAIN ITS VEHICULAR EQUIPMENT AND AIR FORCE POL AND MEDICAL TEAM VEHICLES." RECOMMENDATION: ACCURACY. ALIGNS THE

E. PAGE D-1-5, LINE 11: CREATE A NEW SUBPARA 2H WITH THE SENTENCE BEGINNING, "ALL MOGAS...". RELETTER FOLLOWING SUBPARAS ACCORDINGLY. RATIONALE: EMPHASIS. THIS CHANGE WAS MISSED DURING DRAFT EDITING ON ENEWETAK.

G. PAGE D-1-7, LINES 23-24: DELETE BOTH LINES. PLACE A PERIOD AT THE END OF LINE 22. RATIONALE: CLARITY. LINES 23-24 DO NOT ACCURATELY PORTRAY THE FUELING CONCEPT WHICH WILL BE EMPLOYED. AIR FORCE ASSISTANCE IS NOT REQUIRED WITH THE POSSIBLE EXCEPTION OF LOGGING FUEL ISSUES. MOGAS SERVICING IS SELF-SERVICE AND REQUIRES NO ESC ASSISTANCE.

H. PAGE D-1-8, LINES 1-2: DELETE ENTIRE SUPPARA 3A(7). RATIONALE: REDUNDANT WITH SUPPARA 3A(3). UPDATE FREQUENCIES ARE DETERMINED BY SAPOF.
