ADMINISTRATION FOR EIGHTEEN YEARS. THEIR CAUSE IS JUST CAUSE AND SO I DO NOT INTEND TO GIVE UP EASILY. I ASK YOU TO BEAR WITH ME FOR FEW MOMENTS BECAUSE I WANT TO TELL YOU WHAT MNS STORY SAID. AND I WANT TO TELL YOU WHAT I THINK ABOUT IT.

5. MNS REPORTED ME AS SAYING: "BALSO ACCUSED MICRONESIAN NEWS SERVICE OF MANAGING NEWS TO HIDE FREE EXPRESSION OF IDEAS FROM PEOPLE OF MICRONESIA....PERHAPS BECAUSE THEY ARE CRITICAL OF ADMINISTRATION."

6. WHAT THEY DID NOT INCLUDE IN STORY WAS THAT I ALSO SAID: "PERHAPS IT IS BECAUSE THEY FEAR TRUTH OF STATEMENTS I HAVE MADE."

7. IN MY REMARKS TO THIS HOUSE ON TUESDAY, I SAID THAT IF HIGH COMMISSIONER AND ACTING ATTORNEY GENERAL DID NOT CARE ABOUT PEOPLE OF THESE TWO ISLANDS, MAYBE WE SHOULD DEPORT THEM. I ALSO SAID I WAS CONVINCED UNITED STATES DELIBERATELY ALLOWED THESE PEOPLE TO BE EXPOSED TO RADIOACTIVE FALLOUT.

IN YESTERDAY'S MNS DIRECTOR OF PUBLIC AFFAIRS SAID HE WAS "SHOCKED I WOULD MAKE SUCH "FALSE AND GROSSLY IRRESPONSIBLE CHARGES."

9. NOW, WHILE I HAVE GREAT RESPECT FOR THIS MAN, I ALSO REALIZE HE IS DOING A JOB. I AM SURE THAT IF HE WERE STILL A U.S. CONGRESSMAN AND IT WERE HIS CONSTITUENTS FROM PENNSYLVANIA THAT WERE MAIMED, DISABLED AND STRIKEN BY RADIOACTIVE FALLOUT, HE WOULD NOT CEASE HIS EFFORTS TO SEEK JUSTICE FOR THEM. THAT IS KIND OF HUMAN PERSON I THINK HE IS. BUT I WOULD LIKE TO STATE THAT JUST BECAUSE AN OFFICIAL OF GOVERNMENT SAYS CHARGES WERE

HE SAID I HAVE BEEN GIVEN DETAILED MEDICAL INFORMATION ABOUT PEOPLE ON RONGLAP AND ULIRIK.

11. INFORMATION SUPPLIED TO ME BY DEPARTMENT OF HEALTH SERVICES IS VAGUE AND GENERAL. WHAT IT NORMALLY SAYS IS THAT RADIATION LEVELS IN PEOPLE ARE LOW. I DO NOT THINK THAT IS VERY DETAILED.

12. DIRECTOR ALSO SAID "WE REGRET REPRESENTATIVE CHOOSES IGNORE AND DISTORT INFORMATION."

13. MAYBE HE THOUGHT I DREW MY CONCLUSIONS FROM DEPARTMENT OF HEALTH SERVICES REPORT. HE SHOULD HAVE LOOKED AT HOUSE JOURNAL. MY SO-CALLED DISTORTIONS OF INFORMATION WERE BASED ON OPINIONS OF JAPANESE MEDICAL EXPERTS, WHICH CONGRESSMAN SETIK INSERTED INTO THE JOURNAL.

14. MNS STORY THEN QUOTES DIRECTOR OF PUBLIC AFFAIRS AS SAYING MNS AND MBS DO AND WILL CONTINUE REPORT "

15. WHAT HE DID NOT SAY WAS MICRONESIAN BROADCASTING SYSTEM SUPPRESSED MY SPEECH UNTIL HIGH COMMISSIONER COULD COME TO PALAU TO MAKE RESPONSE. I HAVE HERE LETTER FROM BROADCAST PEOPLE TO PUBLIC AFFAIRS PEOPLE WHICH SAYS IN PART: "WE ARE NOT, AT THIS POINT IN TIME, GUILTY OF HIS ACCUSATIONS. WE ARE GUILTY, HOWEVER, OF "SITTING" ON STORY UNTIL BALANCE OF STATEMENTS BETWEEN BALOS AND ADMINISTRATION CAN BE OBTAINED."

16. ENGLISH MAY BE SECOND LANGUAGE FOR ME, BUT I THINK THERE IS NOT MUCH DIFFERENCE BETWEEN SUPPRESSING STORY AND SITTING ON IT. AS FAR AS I KNOW, ADMINISTRATION NEVER GETS ON ITS OWN STORIES. THIS KIND OF DICTATORIAL CONTROL OF NEWS SERVICE LEADS ADMINISTRATION TO NEGLECT ITS PRIMARY DUTY TO KEEP PEOPLE INFORMED. ADMINISTRATION HAS MADE BIG MESS OF THIS ISSUE. THEY COULD HAVE AVOIDED

IT BY SIMPLY BROADCASTING WHAT I HAD TO SAY AND THEN PRESENTING THEIR SIDE OF IT.
