RADIATION PROBLEM

- PEOPLE TO LIVE ON ISLANDS CONTAMINATED BY FALLOUT.
- UPTAKE IN SEAFOODS VERY LOW.
- UPTAKE IN AGRICULTURE PRODUCTS HIGH.
- RESTRICTION REQUIRED ON FOODS AND HOUSING.
- LONG-TERM MONITORING ENVIRONMENT AND PEOPLE REQUIRED.
- FEDERAL STANDARDS MAY BE LOWERED.
