1. Enclosure (1) represents 13 pallets/11,675 pounds/570 cubic feet/14 measurement tons of Project Handclasp material delivered to Defense Nuclear Agency, Field Command Pacific Support Office, Hawaii for transshipment to Enewetak. On 8/9 April numerous dignitaries representing the United States will attend ceremonies returning the atoll to the people of Enewetak. These 13 pallets of gifts will be presented to the people of Enewetak as part of the celebration.

2. Background-information concerning preparation and applicability of the materials listed in enclosure (1) follows:

a. Two pallets of J&J medical kits. Estimated value of each pallet is \$2,500 (enclosure (2)).

b. Three Project Handclasp Sewing Machine Workshops. Each workshop consists of a new treadle sewing machine, 50 yards of material, scissors, assorted buttons, needles, thread, and other sewing notions as well as Instant Replay, diapers, medical consumables, etc., used as filler. These workshops are valuable in that they give an enterprising recipient the capability of beginning a self-sustaining profession, as well as maintaining clothing for his own family. It is important that these workshops be given to recipients who will put them to good use, and that feedback be forwarded to the donor listed on each document, copy to this office. It would be a thoughtful gesture if the Defense Nuclear Agency would award a plaque, picture, letter/certificate of appreciation, or some other keepsake to the donors. A name-plate, inscribed with an appropriate inscription and affixed to the underside of the sewing machine, would be a lasting memento, for example:

with the inscription of one element (Army, Navy, Air Force) for each sewing machine. These Sewing Machine Workshops are being provided in hopes that feedback will be provided as discussed above.

c. Three pallets of laundry compound. Each pallet weighs 1,500 pounds and contains approximately 30 cases: seven cases each of laundry soap, laundry booster, bleach, dishwashing compound, and two cases of concrete cleaner. These cleaning products are highly concentrated; therefore, it is recommended that the ultimate user be advised to follow the directions on the container of each product.

d. Two pallets of schoolbooks. One pallet of elementary books and one pallet of junior high books. Each pallet contains approximately 1,000 books.

e. One pallet of flower and vegetable seeds consisting of eight small barrels, approximately 5,000 packages. For proper germination, instructions on each package should be followed.

f. One pallet containing two bolts of yellow fabric (50% cotton/50% polyester), four boxes of Jack-in-the-Box uniforms (approximately 150 tunics/shirts), 20 puzzles/games, and 130 Captain Kangaroo dolls.

g. One pallet containing two bolts of lavender fabric (93% rayon/7% silk), two cases of carbohydrates (each case weighs approximately 90 pounds and contains two cans of hard candy), 216 WHAMO Flurries, 400 J&J First Aid kits, 6 athletic balls, and 20 Captain Kangaroo dolls.

3. Feedback

a. Project Handclasp provides material to those commands/organizations which have expressed the greatest interest, including maximum participation, effective distribution, and feedback. No donor, whether individual or corporate, will continue to provide material to Project Handclasp without being apprised of how their material has been utilized and the results obtained from this utilization. It is through feedback that Project Handclasp is able to obtain materials sent overseas.

b. Pictures obtained during the distribution (both black and white, with negatives, and color slides) are desired. Submission of magazine/newspaper articles to local/national news media, such Navy publications as NAVY TIMES, CHINFO WEEKLY NEWSGRAM, ALL HANDS, NAVNEWS, etc., and similar Army/Air Force publications would be most beneficial.

c. It would be appreciated if correspondence, signed preferably by the Director, discussing the distribution, value, acceptance, etc., of the shipment, as well as the impact of the program on furthering Navy objectives to include "improving perceptions of the Navy" and the United States, be sent to West Coast Director, Project Handclasp, copy to CNO, CINCPACFLT, COMSEVENTHFLT, COMELEVEN, etc.

4. This shipment demonstrates how the "hand of friendship" can extend from the people of America to the people of Enewetak in honor of this historic event. We are proud to be a part of your effort.
