THE SPECIAL MEDICATION, TO PROVIDE INTERIM RELIEF UNTIL MEDEVAC COULD BE EFFECTED, WAS PROVIDED BY AIR DROP FROM A P-3 AIRCRAFT. EXTENSIVE COORDINATION BETWEEN THE MEDICAL FACILITIES, AVIATION UNITS, AND SUPPORT PERSONNEL ON GUAM, ENEWETAK AND AT SEA WAS REQUIRED TO CARRY OUT THE MEDEVAC IN SUCH A TIMELY MANNER.
