3. THE FIRST AID KIT WAS PROBABLY PUT TOGETHER BETWEEN 1967 AND 1971. MOST OF THE ITEMS IN THE KIT HAD AN EXPIRATION DATE OF 1973. THE KIT HAS BEEN TURNED OVER TO THE HOSPITAL
