

Dear Dr. Scheele:

While no biomedical experimentation is planned for this autumn in connection with atomic detonations, it is important that at the earliest opportunity we conduct certain experiments especially in the area of the biological effect of neutrons. It now appears that such an opportunity will be forthcoming in a series of detonations at the Hevada Test Site in the spring of 1953.

The Riomedical Test Planning and Screening Committee, of which Dr. Howard L. Andrews of your organization is a member, is new completing the review of a number of experiments particularly suitable to this test.

We have requested that Commander Eugene?. Cronkite, MC, USN, be assigned to direct the execution of this experimental program. Commander Cronkite feels it would be very desirable and conducive to the efficient conduct of these intricate experiments if he could be assisted by Dr. W. T. S. Thorpe, Chief, Section of Comparative Pathology, MIH, and Dr. George Brecher, Pathologist, MIH. Both of these men have demonstrated, by their past collaboration with Dr. Cronkite, their special fitness and ability in the field of the effects of radiation and large-scale handling of small animal colonies.

Since this particular study is simed at some of the Public Health problems concerned with the evaluation of shelters and the determination of hazards in shelters, we especially request the assignment of Drs. Thorpe and Precher to Commander Cronkite's team for a period of approximately six weeks during March and April, 1953.

In the event this request is approved, it is suggested that Drs. Thorpe and wecher contact Commander Cronkite for further details.
