1. (C) A MODIFIED NUCLEAR TEST READINESS PLAN UNDER DEVELOPMENT PURSUANT DECDDEF DIRECTIVE WILL DISESTABLISH JTF-3 AND DEACTIVATE READINESS FACILITIES AT JOHNSTON ISLAND. AIR FORCE TO TAKE OVER OPERATION OF JA. UNDERSTAND CORRESPONDING AEC CHANGES OVERSEAS ARE UNDER STUDY.

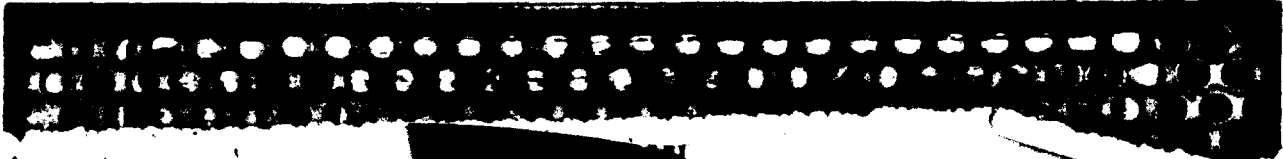

(C) PRIOR TO THIS READINESS POSTURE MODIFICATION IT HAD BEEN PLANNED TO REPLACE AEC AND DOD EQUIPMENT MOVED FROM JA AND ELSEWHERE TO BIKINI FOR CLEANUP, AND SUBSEQUENTLY TRANSFERRED TO ITG AT BIKINI. I NOW PLAN TO REPLACE NONE OF THIS DOD EQUIPMENT, WITH POSSIBLE EXCEPTION OF SOME NEEDED BY AIR FORCE TO OPERATE JA, WHICH INTEND TURN OVER TO THEM WITH ISLAND TURNOVER.
