HOWEVER, LAST UN MISSION (1973) DID VISIT BIKINI AND OUR VERBAL REQUEST FOR ACCOMODATIONS ON APRIL 4 ERDA CHARTER WAS MADE IN ANTICIPATION OF GROUP'S POSSIBLE DESIRE TO VISIT BIKINI. WE WILL TRY TO CONFIRM UNVM'S PLANS AND INFORM ERDA ASAP. IF BIKINI TRIP CONFIRMED WE WOULD LIKE TO SHARE APRIL 4 CHARTER. IF UNVM SCHEDULE PRECLUDES JOINT PAGE 02 RUEGSAA3439 UNCLAS.  
 CHARTER OF 4 APRIL FLT THEN WE WOULD PROBABLY ARRANGE SEPARATE CHARTER FOR UNVM TO BIKINI. WE WILL KEEP YOU POSTED. FURTHER INFO ON UNVM MAY BE OBTAINED FROM LAW, TT LNO HONOLULU. REQ ALSO PERMISSION IN ADVANCE IF THE VISITING MISSION SHOULD DESIRE TO VISIT ENIWETOK. DISTAD DE BRUN
