RONGELAP AND UTIRIK REFERRAL PROGRAM

FOLLOWING IS A SUMMARY OF A PRELIMINARY DRAFT AGREEMENT BETWEEN THE TRUST
TERRITORY OF THE PACIFIC ISLANDS AND THE U.S. ATOMIC ENERGY COMMISSION
WITH SUGGESTED CHANGES BY THE JOINT COMMITTEE ON RONGELAP AND UTIRIK.

- 1 AEC AGREES TO PROVIDE FUNDS IN AN AMOUNT NOT TO EXCEED \$20,000 PER ANNUM,
- 2 ON A REIMBURSABLE BASIS, SUBJECT TO THE FOLLOWING CONDITIONS:
- 3 1. THE TERM OF THIS AGREEMENT SHALL BEGIN ON THE DATE OF ITS EXECUTION
- 4 AND, SUBJECT TO EXTENSIONS MUTUALLY AGREED TO BY THE PARTIES OR THEIR
- 5 SUCCESSORS, SHALL EXPIRE ON JUNE 30, 1975 1984.
- 6 2. THE ESTIMATED COST UNDER THIS AGREEMENT IS \$20,000 PER ANNUM ~~AND~~
- 7 ~~PAYMENTS WHEREUNDER SHALL NOT IN THE AGGREGATE AT ANY TIME EXCEED THIS~~
- 8 ~~AMOUNT~~; PROVIDED, HOWEVER, THAT THE PARTIES SHALL REVIEW ANNUALLY THE
- 9 AMOUNTS PROVIDED BY THE AEC UNDER THIS AGREEMENT AND SHALL, UPON THEIR
- 10 MUTUAL CONSENT, AMEND THE AMOUNTS PROVIDED HEREIN. REIMBURSEMENT WILL
- 11 BE MADE QUARTERLY FOR ACTUAL COSTS INCURRED ON RECEIPT BY THE AEC OF
- 12 DETAILED EXPENDITURE STATEMENTS FROM THE TRUST TERRITORY.

- 1 3. IT IS EXPRESSLY UNDERSTOOD AND AGREED THAT THE COMMISSION'S REIMBURS-
2 MENT HEREUNDER SHALL BE LIMITED TO RESEARCH-RELATED EXPENDITURES INCURRED
3 BY THE TRUST TERRITORY IN ACCORDANCE WITH THE FOLLOWING PROVISIONS:
4 (A) REIMBURSEMENT SHALL BE PROVIDED ONLY FOR PERSONS ON THE ROSTER OF
5 THE BROOKHAVEN MEDICAL SURVEY TEAM; THE ROSTER ~~INCLUDES~~ SHALL INCLUDE
6 ONLY EXPOSED PERSONS, DESCENDENTS OF EXPOSED PERSONS AND DESIGNATED
7 CONTROL PERSONS. (B) REIMBURSEMENT SHALL BE PROVIDED ONLY IN THE CASE
8 OF MEDICAL ILLNESS (NOT INCLUDING INJURIES DUE TO ACCIDENTS UNRELATED
9 TO IRRADIATION) WHICH REQUIRE TRANSPORTATION TO A DISTANT SITE FOR CARE,
10 AND SHALL INCLUDE THE FOLLOWING CLASSES OF EXPENDITURE: (i) TRANSPORTATION
11 BY FIELD TRIP SHIP TO INCLUDE FARE AND MEALS; AND (ii) PER DIEM OF \$9.00
12 FOR THE PATIENT AND ALSO \$9.00 FOR ONE PERSON ACCOMPANYING THE PATIENT.
- 13 4. A REPORT OF ACTIVITIES CONDUCTED UNDER THIS AGREEMENT WILL BE SUB-
14 MITTED ~~AT LEAST 60 DAYS PRIOR TO THE RENEWAL DATE OR~~ NO LATER THAN
15 APRIL 30/ 1973 OF EACH YEAR DURING THE TERM OF THIS AGREEMENT AND ANY
16 SUCCEEDING YEAR(S) PROVIDED FOR IN AN EXTENSION OF THIS AGREEMENT.
- 17 5. DELETE THIS PART REGARDING INDEMNIFICATION IN ITS ENTIRETY.
