COMPUTER REDUCTION OF HIGH ENERGY DATA, WITH PHOTO OVERLAYS OF INTENSITY CONTOURS, COMPLETE ON FRED, ELMER, YVONNE, JANET, IRENE, BELLE, AND URSULA. DATA ON FRED INDICATED TWO SMALL AREAS SIGNIFICANTLY ABOVE BACKGROUND. A FIELD CHECK SHOWED ONE TO BE A SMALL COBALT 60 SOURCE STORED IN A LOCKED BUILDING. IT BELONGS TO USGS AND IS IN FARKADYS CUSTODY. THE SECOND SOURCE, (10 MICRO R, OR APPROXIMATELY TEN TIMES BACKGROUND) WAS FOUND TO BE A STACK OF BARRELS OF FLY ASH STORED IN THE PACE DRILLING EQUIPMENT WAREHOUSE. NO PROBLEM
