UNCLAS IN PARTIAL ANSWER TO YOUR INQUIRY REGARDING THE STATUS AND PROGRESS OF THE RESURVEY OF BIKINI ATOLL, THE FOLLOWING INFO IS SENT. A MEETING WAS HELD AT THE AEC H STREET OFFICE, FEBRUARY 20, 1968, TO DISCUSS PRELIMINARY RESULTS OF THE BIKINI ATOLL SURVEY OF APRIL-MAY 1967, AND TO CONSIDER ACTIONS BY THE FEDERAL GOVERNMENT IN RETURNING THE NATIVE POPULATION TO BIKINI ATOLL IN THE NEAR FUTURE.

ATTENDEES INCLUDED THE HONORABLE NORWOOD, HIGH COMMISSIONER OF THE TRUST TERRITORY AND PERSONNEL FROM THE ATOMIC ENERGY COMMISSION AND OTHER GOVERNMENT AGENCIES.
