TO EXPLORE THIS FURTHER WHEN YOU ARE IN HONOLULU THE LATTER PART OF
THIS MONTH. OUR CONTRACTOR, HOLMES AND NARVER, MAINTAINS A RECORD
CENTER FOR THE AEC IN LOS ANGELES AND THE ORIGINAL DRAWINGS CONCERNING
