On the evening of December 7, 1952, Messrs. Gilleran, Van Dine, and David L. Narver, Jr. flew to Albuquerque and stayed overnight at the Hilton Hotel. The following morning the three proceeded to the AEC-SFCO offices for a meeting in Mr. Rube Cole's office. AEC was represented by Messrs. Rube Cole, P. W. Spain, James Reeves, Ralph Johnson, and C. Goris.

The meeting discussed the advanced thinking for new work and monies available for present work, base improvement, and future work. The fiscal portion of the meeting is covered by Mr. Gilleran's memo dated December 10, 1952, Trip to Albuquerque - December 8 and 9.

The remainder of the meeting is covered by Mr. Spain's letter No. PG-1-1307 (Restricted Data) in which he outlines work for us to undertake.

On December 9, David L. Narver, Jr. visited Los Alamos and had informal discussions with Messrs. Robert Campbell, Wm. Ogle, Stanley Burriss, and Dr. Alvin Graves. The net result of the visit being that Los Alamos is not yet ready to release any design information but hopes to have some by the latter part of January. Dr. Graves is setting up a working procedure so that University of California Research Laboratory at Livermore will have a means of requesting real estate and approval of experiments.
