TWO CH-53 HELOS AT KWAJALEIN BEFORE DARK, NOV. 3 KWAJ LOCAL. SUBJECT HELOS ARE TO STAGE FROM KWAJ ON/ABOUT NOV. 8, 1972, IN SUPPORT OF AEC RADIOLOGICAL SURVEY OF ENIWETOK, REMAINING ENIWETOK FOR APPROX. TWO WEEKS.

PURSUANT TO ARRANGEMENTS MADE INFORMALLY WITH MR. STEENVERS OF GLOBAL ASSOCIATES AT KWAJ, NV REQUESTS THE USE OF PARKING SPACE ON THE MAIN RAMP AND COVERED WORK AND STORAGE SPACE FOR PREPARATION OF TECHNICAL EQUIPMENT INSTALLATION. - A. PERMISSION, ON A NONINTERFERENCE BASIS, TO FLY A SMALL NUMBER OF SHAKEDOWN MISSIONS AT KWAJALEIN DURING THE PERIOD NOV. 5, 6 AND 7. SUCH MISSIONS WOULD INCLUDE LOW-LEVEL PASSES OVER SUCH LAND MASS AND REEF AREAS AS KMR MAY DESIGNATE AND WOULD INCLUDE PHOTOGRAPHY THEREOF. PHOTO TECHNICIANS ARE ALL "Q"-CLEARED AND PHOTOS WOULD, OF COURSE, BE SUBJECT TO KMR SECURITY REVIEW.
- B. UTILIZATION OF A SMALL AIR-CONDITIONED SPACE WITH RUNNING WATER -- POSSIBLY A DORMITORY OR TRANSIENT HOTEL ROOM -- TO BE USED AS A TEMPORARY DARKROOM.
