

PROGRAM OUTLINE

- 1. DEVELOP RADIOLOGICAL CRITERIA FOR EVALUATING CONDITIONS FOR HABITATION OF TEST ATOLLS IN THE PACIFIC.
- 2. DEVELOP RECOMMENDED PRECAUTIONS AND RESTRICTIONS THAT ARE NEEDED TO KEEP

 RADIATION ÉXPOSURES OF MARSHALL ISLAND RESIDENTS WITHIN ACCEPTABLE CRITERIA.
- 3. CONDUCT A LONG TERM FOLLOWUP RADIOLOGICAL MONITORING PROGRAM FOR THE PEOPLES
 AND ENVIRONMENTS OF NUCLEAR TEST IMPACTED ATOLLS TO INCLUDE BASELINE DATA
 FROM OTHER AREAS OF THE PACIFIC.
- 4. EVALUATE RADIOLOGICAL SURVEY DATA AND MAKE RADIATION DOSE AND BODY BURDEN PREDICTIONS.
- 5. EVALUATE EFFECTIVENESS OF RECOMMENDED PRECAUTIONS AND RESTRICTIONS DESIGNED
 TO LIMIT RADIATION EXPOSURES AND TO INSURE SUCH EXPOSURES ARE WITHIN
 APPLICABLE CRITERIA.

- 6. PROVIDE GUIDANCE AND FUNDING FOR CONTRACTOR ACTIVITIES.
- 7. COMPILE AND MAINTAIN RECORDS OF BASIC DATA AND INFORMATION ON RADIOLOGICAL CONDITIONS IN THE PACIFIC AND INFORMATION ON THE PEOPLE OF THE MARSHALLS.
- 8. CONDUCT A RADIATION HEALTH AND SAFETY EDUCATION AND INFORMATION PROGRAM
 FOR THE MARSHALLESE PEOPLE.
- 9. PERFORM LIAISON WITH AN ADVISORY COMMITTEE ON TEST ATOLLS.
- 10. PROVIDE ADVICE TO DOI, DOD, EPA, TT OFFICIALS AND LEGAL REPRESENTATIVES.
- 11. CONDUCT A PERIODIC REVIEW TO INSURE THAT EXPOSURES OF BIKINI AND ENEWETAK
 RESIDENTS FROM EXTERNAL RADIATION AND FROM RADIONUCLIDES IN THE FOOD
 CHAIN ARE AS LOW AS PRACTICABLE.
- 12. PROVIDE STATE-OF-THE-ART INSTRUMENTATION FOR RADIOLOGICAL MONITORING
 OF THE MARSHALLESE AND THEIR ENVIRONMENT.

- 13. STUDY METHODS FOR REMOVAL OF RADIONUCLIDES IN SOIL THAT MAY BE APPLICABLE TO AN ATOLL ENVIRONMENT.
- 14. STUDY THE ENVIRONMENTAL IMPACT OF DEBRIS DISPOSAL IN THE TEST ATOLLS.
- 15. SUPPORT STUDY OF METHODS FOR MINIMIZING THE LEVELS OF RADIONUCLIDES IN FOOD GROWN AT BIKINI AND ENEWETAK ATOLLS.
- 16. STUDY THE DIETARY AND LIVING PATTERNS OF TEST ATOLL PEOPLES.
- 17. STUDY HOW RADIONUCLIDE LEVELS ARE CHANGING WITH TIME IN THE TEST ATOLLS.
- 18. APPLY NEW MONITORING TECHNOLOGIES WHEN APPLICABLE.
- 19. EVALUATE RADIOLOGICAL ASPECTS OF COPRA PRODUCTION IN THE TEST ATOLLS.
- 20. PROVIDE A LONG RANGE PLANNING FUNCTION DESIGNED TO FORESEE ANY FUTURE RADIOLOGICAL PROBLEMS IN THE MARSHALLS.


