


## ABSTRACT

- 1. The Commission believes that the letters from members of the Joint Task Force appearing in several newspapers have violated the provisions of the security regulations of the Task Force and possibly the Atomic Energy Act.
- 2. AEC is making a full investigation with the help of the Task Force, DOD, and FBI.

As our Division of Security orally advised Mr. Frank Cotter of the Joint Committee staff on Monday, November 10, 1952, the Commission believes that the letters from members of the Jeint Task Force at Eniwetok which have been published in various newspapers and breadcast by radio have violated the security regulations of the Task Force and possibly the provisions of the Atemic Energy Act of 1946.

Since the appearance of the first letter in the Los Angeles Examiner of November 8, we have been following all the lines of investigation available to us through the Task Force, the Department of Defense, and the Federal Bureau of Investigation.

So far the identity of one writer whose name was not given in the news dispatch carrying his letter has been established by the Department of the Navy, and a statement obtained from him. Our information at present is that he was briefed on security requirements surrounding the tests, and did not write the letter in ignorance of its hazard to the security of classified information.

The investigations are continuing. We are determined to get to the bottom of any instances which appear to constitute breaches of security. Mr. Cotter is being supplied with findings as they become available. We will, of course, provide the Committee with a summary of the facts revealed and of final actions taken.
