COMMISSION ACTION ON ABC 129/17 - CURRENT PROGRESS REPORT TO THE JOINT COMMITTEE

1. At Meeting 327 on November 2, 1949 the Commission considered the draft quarterly Progress Report to the Joint Committee for July - September 1949 (AMC 129/17), as amended by AMC 129/19. Also under consideration was a draft Foreword and Appendix "P" to the Quarterly Progress Report (AMC 129/18). The Commission:

- a. Approved, as revised in the light of discussion at the meeting, the draft quarterly Progress report (AMC 129/17) as amended by AMC 129/19, and also approved, as revised at the meeting the draft Foreword and Appendix "B" (AMC 129/18); )
  - b. Requested that revised sections of the report be circulated to the available Commissioners before reproduction of the final report; and
  - c. Requested that the staff explore the possibility of making available regularly to certain members of the President's staff an information copy of the Quarterly Progress Report, under appropriate security safeguards.

2. The General Manager has requested that you take the necessary implementing action on this decision. He would appreciate a memorandum as to Commission review of the revised section of the report, for insertion in our files.

3. It is further requested that a copy of the final report and of any other implementing papers be furnished the Office of the Secretary.
