HOT SPOT APPEARS TO CENTER ON SGZ. SCRAP METAL READING 4 TO 5 MR/HR ALSO FOUND IN AREA BUT EXTREMELY DENSE VEGETATION PERMITTED ONLY VERY LIMITED EXPLORATION.
